IBC COMPANIES

An IBC Company is a company which is incorporated in Barbados to conduct international manufacturing exclusively for export or international trade and commerce (inclusive of brokering or administrative offices) from within Barbados. This company is however restricted from trading within Barbados.

Such a company must first be incorporated in Barbados and thereafter obtain a license issued from the Ministry of International Trade and Business. This process is rather efficient and may be completed in just 2-3 weeks.

IBC COMPANY BENEFITS

- ◆ Tax on profits and gains
 - 10,000,000 to 20,000,000 - 2.5%
 - 20,000,000 to 30,000,000 - 1.5%
 - Over 30,000,000 - 1%
- ◆ Taxes paid in a foreign country may be credited against taxes paid in B'dos provided that it does not reduce the tax payable in Barbados to a rate less than 1% on the profits and gains in any income tax year.
- ◆ Capital gains are not subject to tax in B'dos.
- ◆ Benefits are guaranteed for at least 15 years.
- ◆ No withholding taxes on dividends, royalties, management fees, interest payments, or other fees paid to non-residents or other IBCs.
- ◆ No exchange control restrictions and financial records may be kept in a foreign country.
- ◆ Expatriate staff are exempt from income tax and exchange control on up to 35%
- ◆ No customs duties on imports of equipment, or other materials for use in its business.
- ◆ Where shares are wholly owned by a trust managed by an Offshore Bank, profits are exempt from Income Tax.
- ◆ No minimum capital requirements.
- ◆ Exemption from public filing of financial documents
- ◆ No investment restrictions
- ◆ Single shareholder companies allowed
